EXEMPTION FOR ANY AEROSPACE MAINTENANCE REPAIR AND OVERHAUL (MRO) & RICE MILLER/WHOLESALE

53A	Any rice miller or wholesaler licensed under the Control of Padi and Rice Act [Act 522]	Packing materials	(a) That the goods are imported or purchased from a registered manufacturer; (b) that the goods shall be used solely for the packing of rice; (c) that the person approved shall pay the sales tax on any goods in column (3) that cannot be accounted for.
